After written examination some of the candidates made complaint that written examination was not conducted in the manner it was advertised. Accordingly NVS, Hqr. vide letter No. F.1-15/2011-NVS(Estt.)/2698 Dated 15th June 2015 directed this office to conduct the written examination afresh as the earlier examination was conducted with multiple choice question paper instead of descriptive answers. In compliance with NVS, Hqr. instruction this office requested to EDCIL, CBSE, New Delhi, Cotton College State University and Punjab University to conduct the written examination of the candidates afresh but none of the agencies requested by this office shown their willingness to conduct the examination. In absence of willingness from outside Govt. Agency for conducting written test for the said post we requested NVS, Hqr. to take up the matter at Hqr. level vide this office letter Dated 14th January 2016.
